AMENDMENTS TO THE BY-LAWS OF THE VILLAS HOMEOWNERS'
ASSOCIATION, INC. A CORPORATION NOT FOR PROFIT

VILLAS HOMEOWNERS' ASSOCIATION, INC., A Florida corporation (hereafter referred to as "Association") and pursuant to Section 10 of the BY-LAWS OF VILLAS HOMEOWNERS' ASSOCIATION, INC. (hereafter referred to as "By-laws") recorded in O.R. book 935, Page 1803, as amended from time to time, of the Public Records of Leon County, Florida, hereby amends the By-laws and any amendment, declaration, additions or instruments affecting the By-laws or Rules and Regulations as follows:

1. Any and all additions to paragraph 2 of the By-laws as follows:
 2. Members' Meetings.
(a) The annual members meeting will be held at a place designated by the Board of Directors at 10:00 A.M. Eastern Standard time, on the first Saturday in the month of April of each year beginning 1993, for the purpose of electing Directors and transacting any business authorized to be transacted by the members. If that day is a legal holiday, the meeting shall be held at the same hour on the next Saturday which is not a holiday.
2. This Amendment shall be effective upon recording in the Public Records of Leon County, Florida.
3. Except as amended by this Amendment, the By-laws and all amendments, declarations, additions or other instruments shall remain unchanged and unimpaired.

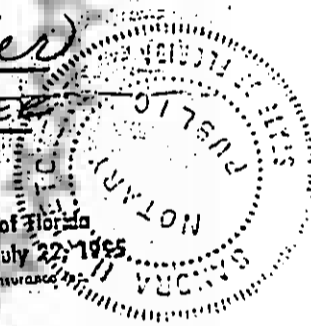
